General Incorporated Association, Japan Accreditation Council for Medical Education Articles of Incorporation, Enforcement Detailed Regulations No. 1

Regulations for Members

(Purpose)

Article 1. These Regulations provide for admission of Members of this Association under the Articles of Incorporation, Article 5 and Article 6 of the General Incorporated Association, Japan Accreditation Council for Medical Education (hereinafter referred to as "this Association").

(Qualification)

- Article 2. The Regular Members shall be deans or presidents of national, public and private faculties of medicine (including schools of medicine and medical sciences, and schools of medicine), medical universities and medical colleges in Japan; and the representatives of the following organizations supporting the development of medical doctors. Their admission shall be approved by the Executive Board upon a prescribed application for admission.
 - [1] Public Interest Incorporated Association, the Japan Medical Association.
 - [2] General Incorporated Association, the Japanese Medical Science Federation.
 - [3] General Incorporated Association, the Japan Society for Medical Education.
- The Support Members shall be organizations supporting the business of this Association, and their admission shall be approved by the Executive Board upon a prescribed application for admission.

(Admission Procedure)

- Article 3. A person who desires to become a Member shall submit the application form for admission, entering the required matters.
- 2. The application form for admission shall be kept at this Association.
- 3. To Members whose admission is approved, the membership approval form (with the issue number) shall be issued in the name of the President.

(Withdrawal)

Article 4. If a Regular Member or Support Member intends to voluntarily withdraw from this Association, the Member shall give prior notice to the President of this Association at least three (3) months before withdrawal.

(Membership Fee)

Article 5. Regular Members and Support Members shall pay membership fees by the respective due dates.

- 2. Membership fees under the preceding paragraph shall be annual fees, and the period shall be one (1) year from April 1 to March 31 of the following year. In case of admission in the middle of the business year, membership fees shall not be monthly prorated, and Members shall pay the amount set forth in paragraph 3 or paragraph 4.
- 3. For a Regular Member, the admission fee shall be 500,000 yen and the annual membership fee shall be 1,000,000 yen.
- 4. For a Support Member, the annual membership fee shall be 100,000 yen per unit, and one unit or more shall be required.
- 5. Membership fees paid shall not be returned except under special circumstances.

(Amendment)

Article 6. These Regulations may be amended by a resolution of the General Assembly of Association Members.

Supplementary Provisions

- 1. Annual membership fees under Article 5, Paragraph 3 shall be 700,000 yen until 2017, notwith-standing these Regulations.
- 2. These Regulations shall be in effect as of December 1, 2015.
